Concerned that corruption may take root in the Counties, the Nation-Anti-Corruption paign Steering Committee (NACCSC) moved to partner with the County Governments early last year to jointly formulate and implement anti-corruption campaian strategies, programmes and activities at the grassroots levels. These include sensitization and awareness creation for County residents on what corruption is, its forms, manifestations, effects and action they should take

whenever they come across it

Specifically members of the public are encouraged to participate in the fight against corruption, become intolerant to corrupt practices and jealously guard against misuse of the resources that have been devolved for development and service delivery, but most importantly, support local and national initiatives to fight corruption.

## Nationwide Anti-Corruption Campaign Gets Fresh Lease

Cognizant of the saying 'prevention is better than cure', the Government recently reconstituted the National Anti-Corruption Campaign Steering Committee (NACCSC) thereby granting it a fresh lease of life. Vide Kenya Gazette Notice no. 6707 dated 19th September, 2014, new Members were appointed to NACCSC for a five-year term within which to actualize the campaign against corruption. The mandate remains that of undertakina a nationwide public education, sensitization and awareness creation campaign aimed at effecting

fundamental changes in the behavior, attitudes, practices and culture of corruption.

Over the years it has become evident that for the war against corruption to be won, there is need for a radical transformation of the mindsets of Kenyans hence the need to adopt a three-pronged approach incorporating investigations, prosecutions and preventive services. NACCSC falls in the latter category.

The new Members comprising 14 in total are drawn from a wide spectrum of society representative of the youth, women, Faith-Based Organizations, trade unions, Government Ministries/Departments and State Corporations. The reconstituted Committee was inaugurated by the Attorney General Hon. Githu Muigai on 24th November, 2014 and thereafter underwent induction from 3rd to 6th December, 2014 where their capacity was built on how to campaign against corruption.

Already the team has approved for implementation the NACCSC work plan for the 3rd and 4th Quarters of the 2014/2015 Financial Year. Among the major ac-

tivities to be undertaken include:-

- Prevention of corruption in the implementation of public projects - Sensitization and awareness creation among Project Management Committees to equip them with skills necessary to promote transparency and accountability in the management of projects and programmes funded by tax payers.
- A values-based anti-corruption campaign – This is premised on the fact that there exists a direct link between the non-practice of values and increased cases of corruption. Already a concept paper on a nationwide Values-Based Anti-Corruption Campaign has been developed, and plans are at an advanced stage to contract a Consultant to actualize the campaign. The objective of this campaign is to sensitize the public on the national values as enshrined in the Constitution of Kenya (2010), and promote
- their practice to change the attitudes, behaviour, practice and culture of Kenyans towards corruption. A nationwide baseline survey is currently being undertaken in partnership with the Directorate of National Cohesion and National Values to inform the successful roll-out of this campaign.
- Partnership and collaboration with County Governments So far, NACCSC has visited and partnered with 32 Counties to jointly formulate and implement anti-corruption campaign strategies, programmes and activities at the grassroots levels. Plans are underway to partner with the remaining 15 Counties in due course.
- Social audits, Public reporting forums, Public barazas and sensitization forums Several social audits have been undertaken by the 19 County Anti-Corruption Civilian Oversight Committees (CACCOCs) already established by NACCSC on pro-

- jects and programmes funded by the tax payer. This is to enhance transparency in the management of these funds as well as equip the public on what to look out for when such funds are expended in their areas. The public is also sensitized on how to identify corruption and become intolerant to it, as well as the steps to take to curb it.
- Collaboration with major stakeholders - The current NACCSC membership comprises a representative of the National Youth Council, Maendeleo ya Wanawake, Inter-Religious Council Kenya and the National Council for People with Disabilities. Efforts are at an advanced stage to partner with these organizations and use their existing structures to reach their diverse membership at the grassroots level, and enjoin them in the campaign against corruption.

On 31st October 2003, the General Assembly adopted the United Nations Convention against Corruption and requested that the Secretary-General designate the United Nations Office on Drugs and Crime (UNODC) as secretariat for Convention's Conference of States Parties (resolution 58/4). The resolution in part reads "7. Decides that, in order to raise awareness of corruption and of the role of the Convention in combating and preventing it, 9th December should be designated International Anti-Corruption Day".

The General Assembly had a vision to see the participation of the public in the fight against corruption, by creating worldwide awareness. In line with the vision of

the General Assembly and to enhance the fight against corruption, Kirinyaga County was for the first time one of the Counties to mark the celebrations.

The strong cordial relationship between the Kirinyaga County Government (KCG), Ethics and Anticorruption commission Nyeri office (EACC/Nyeri) and National Anti-Corruption Campaign Steering Committee Kirinyaga office (NACCSC-KIR) saw a successful and well attended occasion marked at Kerugoya Stadium. A strong professional task force workina on volunteer basis composed of the three main partners KCG, EACC/Nyeri, NACCSC-KIR and the office of the County Commissioner Kirinyaga worked tirelessly to plan and ensure the success

of the celebrations.

The run up to the bia day saw a road show roll out to all corners of the County from the major towns like Wanguru, Kutu, and Kagio to small towns like D'Fathers and Kiangwache where the message of anti corruption rang for two days. Experts in the field of Anti Corruption from the EACC/Nyeri office and the Kirinyaga based local District Anti-Corruption Civilian Oversight committee (DACCOCS) took the time to sensitize and educate the community on corruption and the role of the public in fighting this evil.

The people met the message with joy and attentiveness, with most openly stating that their view of corruption is that 'It takes place in Government offices in Nai-

robi and hence it is the duty of the Government, not them, to fight corruption'. The road shows gave the community the opportunity to share their views in the fight against corruption. "How do you deal with a corrupt police officer who is armed?" they would ask. Their questions were addressed in detail and this indicated the thirst of the community to fight corruption. The road show also gave the public the opportunity to

register their complaints and whereas over thirty (30) people came forth with issues of concern, only nineteen (19) were recorded as genuine complaints to be perused further for action.

The big day 9th December, 2014 came. It started with an 800meter march from Kerugoya town to the stadium led by the Kirinyaga Governor Hon Joseph Ndathi. The excited crowd joined the procession to the

celebration venue. The over 300 people listened attentively to the speeches made by various speakers and all the while chanted in support of the chorus 'Tukomeshe Ufisadi, tuijenge County yetu Kirinyaga'. The flame lit on this day marked a milestone that should ripple towards a positive change in the perception of corruption in Kirinyaga County.

## Malindi Roadshow a Timely Exercise

The National Anti-Cor-Campaian Steerina ruption Committee (NACCSC), the Ethics and Anti-Corruption Commission (EACC), and Transparency International (TI) carried out a very successful Road Show in Malindi to sensitize the public and create awareness on corruption. The road show started in the town centre and moved to Kisumu Ndogo, Majengo, and then to Kijiwe Tanga, Msabaha and Gede. It went through Kakuyuni, to Ganda and back to Malindi.

What measured the success of the road show was not just the blaring music by the event organizers, but the level of attendance and precisely the show of interest by the members of the public in the entire exercise. The response by the members of the public to the questions posed to them by the MC and crew were indicative of the level of awareness about corruption. The public seemed quite aware about corruption. They answered questions like what is corruption very well. They even gave examples of corrupt practices with ease. This level of awareness can be mainly attributed to the frequent campaigns by NACCSC through the Malindi District Anti-Corruption Civilian Oversight Committee (DACCOC) on the fight against corruption.

tion raised by members of the public in most stop overs of the road show was "You are telling us about corruption but what have you done to stop it?" "We always here you people saying the Government is serious about stopping corruption but even today the police in the road blocks are taking bribes and you are doing nothing". We managed to convince them that fighting corruption is an individual decision, and saying no must start with you and me.

The campaign helped us to raise further awareness

about NACCSC by distributing our brochures. In this one road show NACCSC managed to distribute over 500 brochures. There is great need to now create further public awareness in the hinter lands of Kakoneni, Chakama, Bamba, Ganze, Chonyi and Kaloleni and Rabai since MombasaandMalindihavebenefited from frequent road shows.

On the celebration of the World Anti-corruption Day on 9th December 2014, some members of the public complained openly about leaders who were perceived as corrupt. This came out clearly when Hon. Dan Kazungu was interrupted in his speech by a member of the public who interjected and complained saying "you are telling us that corruption is bad but you are yourself very corrupt and we know it in Malindi." The person was however, asked to leave the venue but he had passed the message home.

During the celebrations of the World Anti-Corruption day held on the 9th of December every year, partners under the Kenya Leadership Integrity Forum (KLIF) organizing the event in Bungoma including Ethics & Anti Corruption Commission, Transparency International and the National Anti Corruption Campaign Steering Committee engaged other stakeholders including the County Government of Bungoma, the Judiciary, the Kenya Police and the Office of the County Commissioner Bungoma amidst other County heads of departments. The

theme of this year's Anti Corruption day was 'Tukomeshe Ufisadi Tuijenge Kenya Yetu'.
